- The criteria for total, partial or conditional exemption of parents who are unable to pay compulsory school fees, be determined in accordance with the criteria set out in The Exemption of Parents from School Fees Regulations (as amended in Government Gazette No. 39392 of 17 November 2006)
- These regulations must be interpreted within the framework of the SASA and of the National Norms and Standards for School Funding.
- The School Governing Body shall be entitled to determine the information which it may deem necessary for the just and due consideration of an application for exemption of payment of school fees, noting that the burden of proof and balance of probabilities rests with the applicant.
- A parent who wishes to be exempted from the payment of school fees for a child at Leicester Road School shall apply annually in writing by completing the relevant forms provided by the school and returning the forms to the school. These forms are available for collection from the debt collectors' office before 10 th February 2023. The completed submission to the school must be done by the 25<sup>th</sup> February 2023.
- The parent may be required to attend an interview with the school Bursar, SGB or Principal.

- Applicants will be informed, in writing by the School Governing Body of the outcome within 30 days of the

- Parents may apply to the School Governing Body for assistance in completing applications for exemption by contacting the school.
- This set of resolutions does not prevent a parent or the school from making an arrangement for payment of school fees in a manner other than that prescribed in this set of Resolutions.
